Eglinton Flats Winter Tennis Club - General Club Rules

1. Membership is not transferable. Refunds requested in writing PRIOR to opening day are less a \$25.00 handling fee. After opening day ALL MEMBERSHIPS are non-refundable.
2. When requested, photo identification must be presented to club staff to verify membership.
3. All courts, once booked, must be paid for unless placed on sale and sold. This includes PCT courts.
4. If a group does not show up for scheduled court times, the booking person pays the court fees.
5. Two-hour bookings are permitted at any time, except Monday to Friday 7:00 – 9:00 p.m.
6. Court fees must be paid prior to entering the court area.
7. Proper tennis shoes and tennis attire must be worn at all times.
8. No spectators are allowed on the courts at any time. (Maximum players per court are four).
9. No food or drink is to be taken into the court area at any time, except drinking water.
10. Professional coaching is not permitted on court at any time except by EFWTC designated instructors. No ball hoppers are allowed except for use by professional staff. All play is with three tennis balls only.
11. All members must be rated by the Club to participate in club programs.
12. EFWTC is not responsible for property damaged, lost, or stolen at the club or on club grounds.
13. Members playing with non-members must declare their guests and pay an additional \$15.00 guest fee per hour. Failure to do so will result in a doubling of the guest fee. A non-member may not play with (a) member(s) more than four (4) times cumulatively per season.
14. Non-prime members may play on full member booked courts during prime time a maximum of 4 times per season with a surcharge of \$4.00/hour. Non-prime members may only book prime time courts a maximum of 2 days in advance with the \$4.00/hour surcharge.
15. The use of computer programs to do on-line booking is forbidden and will result in termination of membership.
